



IMPACT - TERMS & CONDITIONS

Please take a moment to read our terms and conditions. National Network of Schools in Partnership (NNSP) & Close Up welcome participation on its programs without regard to gender, race, color, religion, sexual orientation, gender identity, national origin, or disability.

I, the parent or guardian of the student (“Participant”) submitting this enrollment, request that Participant be allowed to participate on your virtual program and agree to these terms:

- *Impact* will be using Zoom to collaborate for whole group sessions and breakouts. By registering for this program, I acknowledge that I have reviewed Zoom’s terms and privacy policies, and I give the Participant permission to use Zoom and all of its functions. While NNSP and Close Up will follow Zoom’s recommended guidelines for securing sessions, NNSP and Close Up are not responsible for any unapproved and/or unsolicited interference with the platform.
- NNSP and Close Up may record sessions on Zoom and have the full authority to use, publish, and display Participant’s images and/or voice as it is contained in any recordings in connection with promoting or marketing the program as NNSP and Close Up determine. The Participant releases and indemnifies NNSP and Close Up from any and all claims by third parties or the Participant in connection with the recordings.
- I understand that the program will require the Participant to interact with other students and NNSP and Close Up staff in a variety of settings. The Participant is ready, willing and able to participate, to treat everyone with respect at all times, and to follow the program rules at all times. The program requires a level of education, maturity, and independence of participants. The Participant must be capable of respectfully attending seminars, following instructions, and collaborating with peers during facilitated and non-facilitated sessions. I affirm that the Participant is capable of meeting these requirements. - I understand that the program payment is due prior to the start of the program and is refundable up to 7 days prior to the start date of the program, after which 100% of all payments are non-refundable. Payment fees are transferable up to 48 hours prior to the start of the program, after which 100% of all payments are non-transferable.
- I understand that if the Participant fails to attend sessions of the program, their enrollment may be cancelled with no option for refund or transfer of payment.
- I understand the Participant will not share Zoom information (including link and/or password) or session materials and resources with any individuals. Failure to comply may result in removal from program without providing a refund.
- I understand that students participating in *Impact* may access Padlet and/or Flipgrid as a way to share and communicate with fellow participants. I understand that Participant’s use of Padlet and/or Flipgrid is completely optional and not required as part of their participation in *Impact*. Should Participant opt-in to using Padlet and/or Flipgrid, I acknowledge that I have reviewed Padlet’s and/or Flipgrid’s terms and privacy policies, and I give the Participant permission to use Padlet and/or Flipgrid and all of its functions.
